TOWN OF NORTH EAST TOWN BOARD REGULAR MEETING JANUARY 9, 2020

Call to order:

Supervisor Kennan called the meeting to order at 7:00 p.m. with the Pledge of Allegiance.

Acceptance of agenda:

On a motion by Councilman Fedele, seconded by Councilwoman Morrison, the following was:

ADOPTED – AYES – 4 (Kennan, Fedele, Midwood, Morrison) NAYS – 0

RESOLVED, to accept the agenda.

Supervisor Kennan welcomed all to the first regular meeting of the year. He provided an update on the Community Development Block Grant award to make the Village and Town Halls ADA compliant. The Village is not proceeding with its renovations due to issues with the Village Hall. The Town has been advised by the County that this will not affect the Town's pursuit of the work needed at Town Hall. He also highlighted the three phases of the highway garage project, and said he would like to work on more active community e-mails and website updates.

Department and Committee Reports:

Police – Officer Rudin presented a report to the Board. He stated that as of January 1, 2020, the NYS Bail Reform Act has created excessive paperwork for all agencies and raised a number of other concerns.

Highway – Highway Superintendent Stevens presented a new Agreement for the Expenditure of Highway Moneys. This agreement reflects the money to be levied and collected in the Town for the repair and improvement of highways, and received from the state for State Aid for the repair and improvement of highways to be expended for general repairs in the amount of \$230,000 to be set aside and expended for primary work and general repairs upon 34.23 miles of town highways, including sluices, culverts, and bridges having a span of less than five feet and boardwalks or renewals thereof.

On a motion by Councilman Midwood, seconded by Councilwoman Morrison, the following was:

RESOLVED, to approve the Agreement for the Expenditure of Highway Moneys.

The salt and sand supplies are at average use at this point. The trucks are experiencing normal wear and tear.

Planning, Zoning, and Building Departments – Reports were distributed to the Board.

Town Clerk – Report was distributed to the Board.

Committee Activity – There is no committee activity.

Appointment to fill vacancy on Town Board:

Supervisor Kennan mentioned the contract with Pine Plains Veterinary Associates. This contract has been in existence and covers the dogs picked up by the Dog Control Officer. It provides for \$22.00 a day to care for the dogs.

Clerk Wheeler read the following resolution into the record:

TOWN BOARD OF THE TOWN OF NORTH EAST

RESOLUTION COMMENCING THE LOCAL LAW ADOPTION PROCESS FOR LOCAL LAW NO. __ OF 2020 ENTITLED: A LOCAL LAW AMENDING §180-55 of the TOWN OF NORTH EAST CODE

WHEREAS, The Town Board appointed a Zoning Review Committee consisting of Jon Arnason, as Chair, and Ralph Fedele, Lance Middlebrook, Greg Osofsky and Julie Schroeder, as members, to review the current provisions of §180-55 of the Town of North East Code relating to signs with a request that the Committee make recommendations to the Town Board for revisions

Town of North East Town Board Minutes January 9, 2020 to the sign code to help insure that the sign law was content neutral, and consistent with the U.S. Supreme Court and New York State decisional law; and

WHEREAS, the Committee has reported back to the Town Board, and to the Attorney to the Town with its recommendations which included recommendation for a re-format of §180-55; and

WHEREAS, the Attorney to the Town has drafted a local law amending §180-55 of the current Town Code by repealing the entire section and substituting, in its place, a new §180-55 which incorporates the recommendations of the Committee; and

WHEREAS, the Town Board has reviewed the local law and has determined that it is acceptable for commencing the local law adoption process; and

WHEREAS, the Town Board has determined that this is a Type II action pursuant to SEQRA and not subject to environmental review.

NOW, THEREFORE, be it

RESOLVED, that the Town Board hereby schedules a public hearing on the adoption of Local Law No. _____ of 2020 for February 13, 2020 at 7:20 p.m.; and be it further

RESOLVED, that the Town Clerk is hereby directed to send a copy of said proposed local law to the Dutchess County Department of Planning and Development in accordance with the requirements of §239-m of the General Municipal Law and to the Town Planning Board for its review and comments; and be it further

RESOLVED, that the Town Clerk is hereby directed to post and publish notice of said public hearing, as required by law, and to make available a copy of the proposed Local Law at the Town Clerk's office during regular business hours.
