Supervisor's Comments:

- There is an attorney/client session after the Town Board meeting to discuss possible litigation against the Town.
- George Kaye was re-elected to the Town Board. Claire Owens ran a very energetic campaign.
- There are currently 381 active cases of COVID-19 in Dutchess County. There are 23 people hospitalized. These numbers represent a tripling of the numbers since last month.
- The northern portion of the Rail Trail is nearly complete.
- During Bulk Trash Day, \$1,600 was collected but cost \$1,900. The fee structure will be reviewed the next time. Thanks were extended to the volunteers
- Condolences to Ron Watson's family for the loss of his great granddaughter.

RESOLUTION APPROVING THE AGREEMENT BETWEEN CPL ARCHITECTURE, ENGINEERING, PLANNING AND SURVEYOR AND THE TOWN OF NORTH EAST FOR ENGINEERING, ARCHITECTURAL DESIGN AND CONSTRUCTION ADMINISTRATION WORK FOR THE TOWN OF NORTH EAST DESIGN OF SHARED HIGHWAY GARAGE PROJECT

WHEREAS, the Town of North East is desirous of moving forward with its plans for the shared highway garage project with the Village of Millerton; and

WHEREAS, CPL Architecture, Engineering, Planning and Surveyor ("CPL") has submitted a proposal to the Town Board for the Design of a Shared Highway Garage dated September, 2020; and

WHEREAS, the proposal has been reviewed by the Town Board; and

WHEREAS, the Town Board has determined that the awarding of this contract falls into the category of professional services, which are exempt from the bidding requirements of §103 of the General Municipal Law; and

WHEREAS, the Town Board has determined that the proposal submitted by CPL is acceptable; and

WHEREAS, CPL has submitted a proposed agreement between the Town and CPL for professional services with regard to the engineering, architectural design and construction administration work for the Town of North East design of the shared highway garage; and

WHEREAS, the proposed agreement has been reviewed by the Attorney to the Town Board and has been determined to be acceptable; and

WHEREAS, the Town Board has determined that because of CPL's past engineering work on Phases 1 and 2 of the highway garage project, that CPL has an extensive working knowledge of the project, the project site and the permitting agencies that will aid in the design and eventual successful construction of the highway garage building.

NOW, THEREFORE, be it

RESOLVED, that the Town Board hereby authorizes the Town Supervisor to execute the Agreement between CPL and the Town of North East for engineering, architectural design and construction administration work for the Town of North East design of the shared highway garage in the same, or substantially similar, form submitted to the Town Board provided the terms of any amendments to the contract are acceptable to both the Supervisor and to the Attorney to the Town, without the necessity for further approval of the Town Board.
