Supervisor’s Comments

We are shocked and saddened by the fatal accident in our Town on Route 22 last Monday.
We are still working on the speed reduction by the Highway Garage on Route 22. The State has ruled on it, giving us 50 yards- which feels too tight. Between the converging of Bielke and Winchell Mountain intersections and the Highway Garage, I feel the State made a mistake. I am speaking to our Assembly person and State Senator.
The high temperatures in the weather forecast are concerning. The Town Hall is serving as a public cooling center today and tomorrow from 9am-5pm. The NE Millerton library is also a cooling center and will be open on Friday.

Approval of Special Abstract for Town Highway Truck Purchase

Josh Schultz of the Highway Department presented details of the new truck purchase. He contacted online and local dealers and tried all three major brands. He requested approval of a purchase of a white 2026 4-door custom, plow-compatible, Chevrolet Silverado 2500HD pickup with extended warrantee from Ingersoll Auto dealership in Pawling. There is urgency from the dealership to purchase this tomorrow.

Posting of the Highway Superintendent Job

Our Town Law currently has a residency requirement for the Highway Superintendent position. Supervisor Kennan proposed the Board follow up at the next meeting with a resolution to change the local

law in order to widen the scope of potential candidates. After the next meeting a public hearing would need to be scheduled in August. Board members were given the draft resolution and proposed new local law as written by the Town Attorney. Questions followed about the job description and places to post the opening. Mentioned were the Town website, Indeed, Facebook, and the newspaper. It was agreed that a posting would refer interested candidates to the Town website and the Town Clerk for a more detailed long form of qualifications. *Councilperson Mayville could not vote on zoom.*
